### Keynote **Bill Fletcher, Author, Scholar, Activist**

**“Is It ‘Race’ Or ‘Class’? How U.S. History Has confounded Organized Labor.”**

Bill Fletcher Jr. is an author, and scholar as national expert on Workers' Rights and Racial Justice. Bill Fletcher Jr has been an activist since his teen years. He has worked for several labor unions in addition to serving as a senior staff person in the national AFL-CIO. Fletcher is the former president of TransAfrica Forum; a Senior Scholar with the Institute for Policy Studies. Fletcher is the co-author (with Peter Agard) of "The Indispensable Ally: Black Workers and the Formation of the Congress of Industrial Organizations, 1934-1941"; the co-author (with Dr. Fernando Gapasin) of "Solidarity Divided: The crisis in organized labor and a new path toward social justice"; and the author of "'They're Bankrupting Us' – And Twenty other myths about unions", "Reimagining Labor Unions: Busting Myths, Building Movements", and "Race to Labor: Can Organized Labor Be an Agent of Social and Economic Justice?". He is also a writer of fiction including "The Man Who Fell from the Sky" and "The Man Who Changed Colors", set in the Southeastern MA and Cape Cod, portraying local working-class characters and Cape Verdean protagonists seeking justice in our region and beyond.

## The Rev. Dr. William Joseph Barber II

Rev. Dr. William J. Barber II is President and Senior Lecturer of Repairers of the Breach, Co-Chair of the Poor People's Campaign: A National Call For Moral Revival, Bishop with The Fellowship of Affirming Ministries, Executive Board Member of the Christian Church Disciples of Christ, and Professor in the Practice of Public Theology and Public Policy and Founding Director of the Center for Public Theology and Public Policy at Yale Divinity School.

He is the author of four books: *We Are Called To Be A Movement*; *Revive Us Again: Vision and Action in Moral Organizing*; *The Third Reconstruction: Moral Mondays, Fusion Politics, and the Rise of a New Justice Movement*; and *Forward Together: A Moral Message for the Nation*.

Dr. Barber served as senior pastor of Greenleaf Christian Church, Disciples of Christ for thirty years and as president of the North Carolina NAACP from 2006-2017 and on the National NAACP Board of Directors from 2008-2020. He is the architect of the Forward Together Moral Movement that gained national acclaim in 2013 with its Moral Monday protests at the North Carolina General Assembly. In 2015, he established Repairers of the Breach to train communities in moral movement building through the Moral Political Organizing Leadership Institute and Summit Trainings (MPOLIS). In 2018, he co-anchored the relaunch of the Poor People's Campaign: A National Call for Moral Revival—reviving the 1968 Poor People's Campaign organized by SCLS, under the leadership of Dr. Martin Luther King, Jr., worker's rights movement, women's rights movement, religious leaders, and people of all races to fight poverty in the U.S.

A highly sought-after speaker, Dr. Barber has given keynote addresses at hundreds of national and state conferences, including the 2016 Democratic National Convention, the homily at the 59th Inaugural Prayer Service for President Joe Biden and Vice President Kamala Harris, the Vatican at Pope Francis's encyclical "Laudato Si': On Care for Our Common Home" and the Pontifical Academy of Social Sciences. In June 2018, he addressed the 5th Uni Global Union World Congress to more than 25 countries.



Dr. Barber is regularly featured in media outlets such as MSNBC, CNN, the New York Times, Washington Post, and The Nation magazine. He was named one of 2020's BET 100 Entertainers and Innovators and one of the 2019 recipients of the North Carolina Award, the state's highest civilian honor. He is a 2018 MacArthur Foundation Genius Award recipient and a 2015 recipient of the Franklin D. Roosevelt Four Freedoms Award and the Puffin Award.

Dr. Barber has had twelve honorary degrees conferred upon him. He earned a bachelor's degree from North Carolina Central University, a Master of Divinity from Duke University, and a doctorate from Drew University with a concentration in public policy and pastoral care.

Jill has served on several nonprofit boards throughout her career. These include leadership roles as the president of the National Association of Commissions on Women, where she worked to increase peer-to-peer learning opportunities to encourage the success of member commissions, chair of the Advisory Board for the Center for Women in Politics and Public Policy, and chair of the Massachusetts Chapter of the National Organization for Women. She currently serves her town as a member of the Library Board of Trustees.

## Dr. Kyaien Conner

Ph.D., LSW, MPH Professor and Donald M. Henderson Endowed Chair, Director of the Center on Race and Social Problems (CRSP) and Associate Dean for Diversity, Equity and Inclusion. Dr. Conner received her BS in Psychology, MSW, MPH with a specialization in Minority Health and Health Disparities, and a PhD in Social Work at the University of Pittsburgh.

Dr. Conner's research investigates the factors that influence disparities in health and mental health service utilization and treatment outcomes for racial and ethnic minorities. She is currently the PI of a research award (PCORI) to evaluate the impact of a transitions in care intervention to reduce health disparities among African American and Latino/Hispanic patients being discharged from the hospital with chronic illness and co-occurring mental illness. She is a co-investigator on a multi-site RO1 (NIMH) to evaluate the efficacy of training volunteers in low-income communities to deliver a brief intervention for depression to their acutely depressed peers in an effort to build community capacity. Dr. Conner is the DEI lead for the NIH funded Advanced Research Institute for Geriatric Psychiatry. Dr. Conner also is focused on the development of policy and legislation which supports health equity.

Dr. Conner wrote a bill that signed into law on 6/17/2021 to restructure the Florida State Office of Minority Health and Health Equity (Senate Bill 404 sponsored by State Senator Darryl Rouson Senate Bill 404 (2021) - The Florida Senate (flsenate.gov) )

Dr. Conner has received several awards for her work including the Distinguished Alumni Award (University of Pittsburgh, 2023), Chancellors Award for Excellence in Civic and Community Engagement, (University of South Florida, 2022), and Black Faculty Member of the year (University of South Florida, 2021).


### **Monica Teixeira de Sousa,**

Monica Teixeira de Sousa, a graduate of Georgetown University Law Center and Brown University, is a Professor of Law at Roger Williams University School of Law where she teaches Property, Family Law, and Race & the Foundations of American Law. Prior to joining the RWU Law faculty in 2022, Monica was a tenured professor at New England Law Boston where she created and served as the director of the First-Generation Students

Program. Before her academic career, Professor Teixeira de Sousa was a staff attorney at Rhode Island Legal Services as a Skadden Fellow where she created a school-based legal clinic at her former elementary school in Pawtucket, Rhode Island. She represented parents and students in school discipline and special education cases, as well as public benefits and eviction defense matters.

Professor Teixeira de Sousa has written and presented on issues of equity and education law and policy. She has worked in the Public Benefits Unit at Rhode Island Legal Services and has engage in pro-bono work in the areas of includes the Housing, evictions, parental rights, and educational access. She also serves on the board of directors of both the Cape Verdean American Lawyers Association and the nonprofit Justice at Work.

Professor Teixeira de Sousa earned her JD from Georgetown University Law Center in 2002 and her BA from Brown University in 1998. Some of her publications include: *Class Houses: Fragility and Disunity in the Ranks of Academe* or *Democratizing the Future of Legal Education According to the Vision of Ivan Illich*, *15 Hastings Race and Poverty Law Journal* 1 (2018)



### **Deb Fastino**

Deb Fastino (she/her) is Executive Director of the Coalition for Social Justice Education Fund. She has 23 years of experience in community organizing, campaign directing, and coalition building. She rose through the ranks, starting as a volunteer to Executive Director in 2012. Deb played a leading role in numerous successful statewide campaigns including the ACT Coalition's healthcare victory in 2006, the founding and conceptualization of Raise-Up Massachusetts that led to ballot victories on Earned Sick Time in 2014 and legislative victories to increase the minimum wage in 2014 and 2018. She led the Paid Family & Medical Leave victory for Raise Up Massachusetts in 2018 and in 2022, played a key role in the millionaire's tax ballot victory. She is currently leading the Coalition for Social Justice Education Fund and the Common Start Coalition that focuses on affordable, accessible, high quality early education and childcare.




### Lisa Lemieux

Lisa Lemieux, a graduate of Labor Studies of UMass Boston, is President of the Greater Southeastern Massachusetts Labor Council and Organizer with the Massachusetts Teachers Association, Vice President with Massachusetts AFL-CIO, Massachusetts Democratic Party elected Senatorial Women and a state committee member and co-chair of the New Bedford Democratic City Committee.

Lisa started her first union job at AT&T in Fairhaven in 1997, became a member of CWA Local 1051 and was elected a steward then a District Vice President all while starting her education in Labor Studies at UMASS Dartmouth and Cornell University. Lisa was elected the first Latina President of the GSMLC in 2017 and has been a delegate for over 18 years and as Parent of the Year from PACE - Parents Alliance for Catholic Education, and Labor Representative and executive Board, Mass Hire Greater New Bedford Workforce Board.

Lisa was formerly an Organizer with 1199SEIU and since 2005 has represented healthcare workers in hospital, nursing home workers and Personal Care Attendants.

### Brenda Quintana

Brenda Quintana, (they/them) is the Labor-Community Training Coordinator and Organizer at (Massachusetts Coalition for Occupational. They support worker centers, community groups, and unions by providing worker education and training on occupational safety and health. Brenda also plays a crucial role in coordinating the Coalition for Cannabis Worker Safety and the Massachusetts Worker Center Network. These initiatives bring together workers, advocates, labor unions, and community leaders to address concerns related to cannabis workers and low-wage immigrant workers in the industry and statewide. Brenda is currently completing their master's degree in Labor Studies at the University of Massachusetts Amherst. They have dedicated over five years to organizing with immigrant worker centers and longstanding labor and community leaders who focus on intersectional anti-oppression community work, and the participation of working-class people and people of color.

Elce Redmond is a long-time labor organizer, youth mentor with EWOC (Emergency Worker Organizing Committee). Elce is a union campaign and strategic community organizer with 35 years of experience across a variety of industries. He has helped unions and grassroots groups with leadership development, contract negotiations, grievance monitoring, fostering community alliances, government lobbying, and fiduciary oversight. Elce has worked with unions and community organizations including roles as the Deputy Trustee with the Bakery, Confectionery, Tobacco Workers And Grain Millers International Union, Lead Policy and Community Organizer with Warehouse Workers for Justice, and community groups and coalitions Chicago, IL, including: the Empowerment Zone, the Coalition to Protect Public Housing, Lead Organizer at the Center for Labor and Community Research, Westside Health Authority, as Lead Organizer/Executive Director with the Northwest Austin Council, Organizer with the Illinois ACORN.



### **Dr. Dean Robinson**

Dr. Dean Robinson is an Associate Professor of Political Science at the University of Massachusetts, at Amherst. He holds a Ph.D. from Yale University in political science and did a postdoctoral training in social epidemiology at the Harvard T.H. Chan School of Public Health. Robinson's research and scholarship focus on Black politics and social thought, and

the political and policy dimensions of racial and class inequalities in health in the United States.

His current projects include a second edition of his book *Black Nationalism in US Politics and Thought* (Cambridge), an empirical study on the antipoverty policy on black and white birth outcomes, and a co-authored book project (with Javier Rodriguez) on politics, economics, and Black-white trends in U.S. mortality. He is co-PI on "MOCHA" Moving Forward: A Community-Based Participatory Research Investigation of Chronic Disease Prevention in Older, Low-income African-American Men; funded by the National Institute of Minority Health Disparities and "Simulation and Decision-Analysis Algorithms for Integrated Modeling of Diseases: A healthy lives for all approach" funded by the NSF.



### **Collique Williams**

Collique Williams, senior organizer, Community Labor United, is a long-time Boston-area community organizer, who comes to CLU from the youth organizing sector. Collique began his change-work as a youth organizer at the Boston-area Youth Organizing Project in 2001 and most recently at The City School, where he cut his teeth building a strong base of young folks shaping their communities.

It was there that he first began working on transportation with the successful Youth Pass campaign, making the connection between accessible transportation for youth and a broader fight for more equitable communities for working-class families.



### **Rebecca Yee**

General Counsel, joined the MTA in 2020 after two decades of exclusively practicing labor and employment law, primarily at large and prominent labor unions.
